

## Webmaster Report

Hello Family!

The laptop computer is set-up so that our website can be viewed during the RSC. It is not connected to the Internet so you will get an error page if you attempt to go to links outside our website.

Changes to meetings received from the Phoneline have been posted and updated in the NAWS database. Activities have been added as requested and removed within a week after they are over. The minutes for the February 2004 RSC have also been posted to the site. I discovered that reorganization of files on our website, <na.org> and others caused JavaScript links in the Horizontal Vertical (HV) and the Home page Drop Down menus to become 'broken '. The validation program used on html links does not work on JavaScript links therefore these will require periodic manual validation. All links have been corrected and manually verified.

With regard to maintenance of the NAWS database, ASC Trusted Servant updates for Northwest Arkansas and Foothills Unity Areas were given to me at the last RSC however I gave them back for additional information. Northwest Arkansas Area form was returned then and I got Foothills Unity Area's form this weekend. Also, Texarkana Area mailed their update. As a reminder, Area Service Committee Registration/Update, New Group Registration and Group Update forms can be found on our website and may be sent to me or to NA World Services in the mail or given to me at any time. Once again, we were unable to work on updating NAWS database meeting information in conjunction with the Outreach Committee at this RSC because the Outreach Chair was absent and no committee meeting was held. Maybe we can work on this at the August RSC.

I discovered the WebMaster OneSuite Phone Card expired August 3, 2003 when I attempted to use it on February 25<sup>th</sup>. I called customer service to re-activate our account, which they did with no problem for a 30-day period. The account would go inactive at that time if we did not recharge it and we would lose the minutes we had already paid for. OneSuite FAQ: How long does my account with OneSuite.com last? -- "Your OneSuite.com phone service will last six months from the date of purchase or six months from the date of your most recent recharge. Hence, in order to keep your account active, you simply need to recharge your account at least once every six months." So, I recharged the account, \$10 minimum, on March 25<sup>th</sup> and our current balance is \$23.97 or approximately 826 minutes remaining. During Website Discussion, there was a consensus to add an annual budget amount of \$20 to Website/WebMaster to be used for minimum recharge of the Phone Card on or before 3/25 and 9/25 annually. Consensus was also reached to present a motion in New Business to extend our domain registration an additional 4 years. We will need to remember that registration of "arscna.org" will expire in early May of 2009 instead of annually!

It was mentioned that a literature shopping cart and a donations portal would be available on the NAWS site in about a month. Consensus was also reached to add links to the two NAWS discussion boards and the literature page. Previously, we had not linked to forum type pages because they would be difficult and time consuming to monitor for the appropriateness of their content. Central Arkansas Area member voiced that if we are going to link to NAWS discussion forums that we should also link to their website, the RSC body agreed. There will be two different pages for links to other NA sites, those related to Arkansas, including the Southern Zonal Forum site, and those outside of Arkansas.
